#### **NEW BUSINESS**

Whereas, Jack Connelly was appointed to the Board of Trustees of the Tacoma Public Library on April 4, 2009, by Mayor Bill Baarsma, and,

Whereas, Jack Connelly was reappointed to the Board of Trustees of the Tacoma Public Library on March 18, 2014 by Mayor Marilyn Strickland, and Whereas, Jack Connelly served as Vice President of the Board of Trustees of the Tacoma Public Library from September 2014 – May 2015, and

Whereas, Jack Connelly served as President of the Board of Trustees of the Tacoma Public Library from May 2015 – September 2018, and

Whereas, Jack Connelly, working together with the other members of the Library's Board of Trustees, confidently guided the Tacoma Public Library through several years of budget challenges, technological change, program developments, new partnerships and Library refurbishments, including

- The refurbishment of the Kobetich, Mottet, Moore, and South Tacoma Branch Libraries, creating more user-friendly and attractive libraries and increasing the number of computers available to patrons.
- The development of a new strategic plan on the growth of library services and programs.
- Meeting the challenges of significant technological change, including the transition to a new ILS (Integrated Library System) and VOIP (Voice Over IP) telephone services, the development of a mobile app, and in partnership with the Washington State Library, providing free, high quality online training with more than 400 courses through the Microsoft IT Academy.
- The expansion of grant-funded library services and programs to better meet the needs of our community, including the Digital Media Lab and the Education and Job Center.
- Providing increased access to library materials through reciprocal agreements with the Pierce County Library System and the Puyallup Public Library, allowing Tacoma residents to check out materials from our neighboring library systems.
- Providing access to all Tacoma Public Schools students through the establishment of the Pathway Card program.

 The restoration of the Assistant Library Director position and introduction of Sunday hours at Kobetich, Moore, and Wheelock Branches.

**Now**, therefore, be it resolved by the Board of Trustees of the Tacoma Public Library that the Board does hereby extend its appreciation and gratitude to Jack Connelly for his work as a member of the Board and for his commitment to exemplary library service for the citizens of Tacoma.

## **DIRECTOR'S REPORT**

Introduction of Mariesa Bus, Public Information Officer

Senior positions recruitment: IT Manager – Zac Matthews starts on April 15, 2019.

The County asked permission to install a Ballot Box at Wheelock, which of course was granted.

Kate also reported that Tacoma Public Libraries will be participating in "Points of Assistance", or Same Day Voting. The State Auditor's office will be releasing more information about it, and Library staff will receive training at the June In-Service day.

Microlibraries – the contract for the library kiosks has been signed. A team of staff are working on the many behind the scenes service pieces that have to be in place before the kiosks are installed anywhere.

Security camera & Card swipe project – this is still underway. Cameras are being installed at the last location, Swasey. The system will not go live until the library has a policy in place.

Kate shared a summary of: February's Communty Listening Session; a presentation she delivered to the Board of Park Commissioners; a presentation she and President Williams delivered to the Community, Vitality and Safety Council Committee; and the March In-Service day.

Kate shared news that United States Senator Patty Murray held a press event at the Main branch, to announce the Digital Equity Bill she will be announcing. She also toured the building, where she observed children playing with a Cubetto, Dot and Dash and the WSL's LEGO Mindstorm robots, learned about the Education and Job Center and the tools and services available there for adult job seekers; visited the Digital Media Lab and learned about the production tools people of all ages can use for free and develop marketable skills as a result; saw the computer classroom, where she learned about the free Microsoft Imagine Academy certification education and exams. Then, she participated in a roundtable discussion, where she heard from two library users.

The Tacoma Rainiers visited the Northwest Room to film a piece highlighting what's great about Tacoma.

Public Information Officer Mariesa Bus reminded the Board that Library Giving Day is April 10, and that donations are being accepted now.

Kate announced the 2019 Tacoma Reads title, *There There* by Tommy Orange. The Puyallup Tribe of Indians is a generous sponsor for the program, and will be a collaborator on programs.

# TRUSTEES' REPORT

President Williams reported on the Community, Vitality, and Safety Council Committee presentation he and Director Larsen delivered this month. He felt the committee was engaged and had great questions; he went on to reiterate his high confidence in Director Larsen and her ability to represent the Library to the community. Thanked Trustee Connelly for his service. (Each Trustee thanked him.)

Vice President Irish reported that she attended the Mayor's State of the City Address and was extremely proud of the time the Mayor spent speaking positively about the Library and Library services.

Trustee Connelly reflected on the decade he served on the Board, and thanked the other Trustees, and Library staff for their dedication. He urged the Board to remember that when services are cut, they usually do not get restored.

Trustee LaFrance reported on the Downtown on the Go's "Friday Forum: Math: Traffic Equations and the Value of Moving People" she and Director Larsen attended in February. She encouraged the other Trustees to attend these Forums; they are good opportunities to extend our connections to the community.

Trustee Hines expressed his appreciation for the copy of the 2019 Tacoma Reads book, There, There by Tommy Orange, which he encouraged everyone to read, and offered to lead a book discussion.
