NEW BUSINESS

RESOLUTION 20045: Request that the Board approves a new contract with Rainier Connect for \$112,500 from September 2020 – June 2021.

Budget Timeline Update

- Budget still in flux – lots of economic uncertainty still
- Major efforts across the City to avoid layoffs
- If Council enacts budget changes, there will be considerable time to enact changes
 - October – Library budget presentation to Council and Trustees
 - November 10th & 17th – City Council budget hearings
- Suggest that a portion of the upcoming Trustee study session is designated to budget planning

Electronic/Virtual Update

- Began TPL to Go Services – piloted with select libraries
 - All locations activated on August 18, 2020
- Digital collection access stats continue to rise throughout Pandemic
- Online library card applications are helping to connect TPL resources to new users during Pandemic

Return to Operations Update

- July 25th all furloughed staff returned to active status
- July 28th –TPL to Go launched at 3 locations
- Aug. 11th – All locations opened book drops
- Aug. 18th – All locations available for TPL to Go
