SUBJECT: Director's Report for March – June, 2020

Time Line of Covid 19 Events -

March 17 – Last Day Libraries were open to the public –

Library wifi has always been and has continued to be available from 6:00 am – 10:00 pm at all 26 library locations.

March 27 - Last day Libraries were open for staff

March 30 – Essential employees only reporting to Main Library or telecommuting,

approximately 31 employees. Staff members who were off work had access to 2 weeks County Pandemic Leave, and 2 weeks Federal Emergency Sick Leave.

Mid April – Employees began to experience furlough. At the highest point PCPL had approximately 260 of the 584 staff members on furlough.

More than 50 staff members assigned to other departments to help provide essential services in the Office of Emergency Management, Pima County One stop, Housing Center services, Food Distribution, and temperature taking throughout the County.

April 13th – called staff back to work Infoline and Ask-a-Librarian service Ordering of PPE and Cleaning supplies as well as development of signage and barriers, plexiglass and stations began to prepare for opening.

April 24th – Branch Managers recalled to work 4 hours per week, then 8 hours per week to help with staff time reporting and decision-making.

The original plan was to open 10 library locations with curbside service and 4 libraries with computer services. However when it was determined that the stay-at-home order was likely to be lifted, the plan shifted.

May 11th – Many staff called back to work to have as many libraries as possible open in some capacity for May 18th.

May 18th – Libraries reopened with holds pick up in 24 locations and computers available in 17 locations. River Center closed for renovations, El Rio closed for renovation and waiting for center to reopen. Libraries opened with the requirement of all staff and public wearing masks and having temperatures taken.

June 8th – 23 Library locations open with holds pick up and limited computer sessions The next phase of reopening will be to allow browsing of the library stacks, however we feel very strongly that this cannot happen until the Covid cases in Arizona is declining.

Staffing -

Currently we have 49 vacancies and 31 staff out with medical attestations to remain out of work. Seven staff members are telecommuting. The Library Department received an exemption from the hiring freeze to fill our vacant Library Branch Manager positions as well as our Accounting Specialist positions. We plan to ask for further exemption once the two recruitments are completed.

Challenges –

Closing 26 library locations was no small feat and reopening those locations even in a limited fashion has proved a daunting task. We started with limited services Monday through Friday 10 am – 5pm as a starting point. We realize now that we need to include some later times and/or weekend time. We will be working over the next month to recommend a better schedule that accommodates our current staffing situation and provides time for customers.
