This notice describes how private information about you may be collected, used and disclosed, and how you can get access to this information. Please review it carefully.

General Policy

Personal information provided to the _____ through this portal is considered confidential. The _____ is a publicly-funded entity, and will protect the confidentiality of personal information to the extent permitted under state and federal law. All electronic information is kept in secure databases that are not directly accessible from the internet. Personally identifiable information will not be disseminated unless required as part of a specific program, such as a scholarship, unless required by law.

Why do we ask for this information?

- To tell you apart from other people with the same or similar name;
- To verify the information that you submit, decide the career lattice level you are eligible for, and/or give you credit for training or experience; and
- To make reports, do research, do audits, evaluate our programs and for other administrative purposes.

Do you have to answer the questions we ask?

You do not have to give us your personal information. We need this information to properly track your training and experience. Without the information, we may not be able to give you credit for your training and experience.

With whom may we share information?

We will only share personal information about you with others if:

- We have your consent to share the information, or
- We need to share your information to provide the product or service you have requested, or
- We are authorized to do so by law. E.g., to respond to subpoenas, court orders, legal process, or to requests pursuant to a statute requiring or permitting disclosure such as the Michigan Freedom of Information Act, MCL 15.231, et seq.

We limit access to personally identifiable information gathered through Michigan.gov to employees and agents who need access to perform a specific job. Security measures have been integrated into the design, implementation, and day-to-day operations of this website as part of our continuing commitment to the security of electronic content as well as the electronic transmission of information.

Michigan.gov uses Secure Sockets Layer (SSL) technology to encrypt and protect your personal financial information during Internet transmissions.
